# **PRICING**

We endeavour to hold prices for a minimum of a year, but we do reserve the right to increase prices in response to increases in costs and/or other economic factors. Price changes will not be notified in advance except by arrangement. All prices quoted are exclusive of VAT which will be charged where appropriate.

## DELIVERY

Our standard delivery fee is £5.95, with a small surcharge for Highlands and Islands and for Northern Ireland. Free delivery is available for UK mainland orders over £99. Deliveries will normally need to be signed for. Orders must be received by 4pm and delivery is Monday to Friday, between 9am and 6pm. Upgrades to Priority (eg pre-noon) or Saturday delivery are available for an additional fee.

### INVOICING

Invoices will be emailed automatically to your preferred email address. Copy invoices, statements and any other administration can be sent to any address required.

### **CLAIMS**

All claims for damaged or incorrect goods must be notified by email or telephone within 24 hours, and goods retained and made available for collection or inspection. Refunds and returns made at a later date will be considered solely at MSK's discretion.

#### ACCOUNTS

Credit accounts are available upon request, subject to satisfactory credit checks. Credit limits will apply.

All monies are due within 30 days of receipt of the goods. All goods remain the property of MSK until payment has been made in full. We reserve the right to charge interest of 2% over base rate on all overdue accounts. Interest charges on overdue accounts are not applicable if the invoice is genuinely under dispute.

MSK reserves the right to restrict, limit or remove credit terms for accounts in arrears or over limits, or in response to an adverse notification from a credit rating agency.
